SUBJECT: 2025-12R, 2026-05R, AND 2026-06R: COURTESY NOTICE OF REGULATION WORKSHOP BEFORE THE NEVADA GAMING CONTROL BOARD TO DISCUSS AND SOLICIT COMMENTS REGARDING, WITHOUT LIMITATION, PROPOSED AMENDMENTS TO THE FOLLOWING NEVADA GAMING COMMISSION REGULATIONS 1, 5, 7, AND 25.

The Nevada Gaming Control Board (Board) will hold a regulation workshop to discuss, receive public input, and take possible action to recommend to the Nevada Gaming Commission (NGC or Commission) amendments to NGC Regulations 1, 5, 7, and 25 as part of its regular monthly meeting scheduled for 9:00 a.m. on Wednesday, February 11, 2026, and continue on Thursday, February 12, 2026, at the following locations:

Public comments on the proposed regulatory amendments will be permitted during the workshop.

PURPOSE OF PROPOSED AMENDMENTS

2025-12R: PROPOSED AMENDMENTS TO NGC REGULATION 5 – OPERATION OF GAMING ESTABLISHMENTS: SECTIONS 5.225 (WAGERING ACCOUNTS), 5.240 (SERVICE PROVIDERS), AND 5.242 (CLOUD COMPUTING SERVICES)

PURPOSE: In accordance with *Nevada Revised Statutes (NRS) 463.145, 463.150*, to amend NGC Regulation 5.225 to provide additional permissible methods to deposit and withdraw funds from wagering accounts; to amend NGC Regulations 5.240 and 5.242 to repeal cloud computing service provider as a type of service provider that must be registered with the Board and repeal associated regulatory provisions, and to amend provisions related to who may act as a service provider without registering with the Board as a service provider, and to provide under what circumstances a licensee may utilize cloud computing services; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

REGULATION PROJECT 2025-12R HAS PROPOSED CONFORMING AMENDMENTS AS FOLLOWS:

PROPOSED CONFORMING AMENDMENTS TO NGC REGULATION 1 – ISSUANCE OF REGULATIONS; CONSTRUCTION; DEFINITIONS: SECTION 1.137 (“HOSTING CENTER” DEFINED)

PURPOSE: In accordance with NRS 463.145, 463.150, to amend the definition of “hosting center” in NGC Regulation 1.137 to correspond with proposed changes to NGC Regulation 5.242 regarding cloud computing services; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

2026-05R: PROPOSED AMENDMENTS TO NGC REGULATION 7 – DISCIPLINARY PROCEEDINGS: SECTIONS 7.010 (APPLICABILITY) AND 7.025 (JURISDICTION)

PURPOSE: In accordance with NRS 463.145, 463.150, and [Chapter 78, Statutes of Nevada 2025](#) (Senate Bill 46), to amend NGC Regulation 7.010 to correct and/or modify existing language; to adopt regulations clarifying that the jurisdiction of the Board and Commission in disciplinary matters is fully retained and is not divested in any circumstance, except as otherwise provided; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

2026-06R: PROPOSED AMENDMENTS TO NGC REGULATION 5 – OPERATION OF GAMING ESTABLISHMENTS: SECTIONS 5.045 (COMPLIANCE REVIEW AND REPORTING SYSTEM) AND 5.055 (ACCESS TO PREMISES AND PRODUCTION OF RECORDS), AND NGC REGULATION 25 – INDEPENDENT AGENTS

PURPOSE: In accordance with NRS 463.145, 463.150, to amend NGC Regulation 5.045 to require licensees or registrants subject to a compliance review and reporting system requirement to designate those individuals responsible for the anti-money laundering program and the marketing department and such individuals shall be subject to administrative approval; to create a new regulation to require certain compliance personnel to be found suitable or licensed; to create a new regulation to prohibit third-party business entities from funding a patron’s wagering activities; to create a new regulation to deem anti-money laundering program compliance officers gaming employees; to amend NGC Regulation 5.055 to create a new subsection to create reporting requirements to the Board when a licensee terminates or separates from service a gaming employee for reasons that include failure to comply with anti-money laundering policies and procedures and to take such additional action as may be necessary and proper to effectuate these stated purposes.

PURPOSE: In accordance with NRS 463.145, and 463.150, to amend NGC Regulation 25 to define “secondary representative”; to specifically require licensees to notify the Board if an independent agent is terminated for reasons that include failure to comply with the licensee’s anti-money laundering program; to impose requirements related to the use of secondary representatives; to require additional provisions that must be contained in the agreement between a licensee and an independent agent regarding the activities of the independent agent, regarding restrictions on paying compensation to an independent agent when the source of funds of a patron cannot be established, and their secondary representative; to impose requirements related to anti-money laundering training for independent agents and due diligence of independent agents, and to take such additional action as may be necessary and proper to effectuate these stated purposes.
