SUBJECT: 2025-12R and 2026-01R to 2026-05R: ADOPTION OF AMENDMENTS TO REGULATIONS OF THE NEVADA GAMING COMMISSION AND NEVADA GAMING CONTROL BOARD

At its meeting on March 26, 2026, the Nevada Gaming Commission (NGC) adopted amendments to certain provisions of the NGC Regulations, as identified below. The amendments became effective upon adoption on March 26, 2026. The adopted amendments have been codified into the pertinent chapters of the NGC Regulations.
