COMMISSION WILL \underline{NOT} CONSIDER ADOPTION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 5.260 REGARDING, WITHOUT LIMITATION,

CYBERSECURITY, AS STATED IN PREVIOUSLY ISSUED NOTICE NUMBER 2025-94.

To allow more time to address comments and requested changes to the Nevada Gaming Commission (Commission or NGC) Regulation 5.260 draft dated November 6, 2025, received during the Nevada Gaming Control Board (Board) meeting on December 4, 2025, the Commission will <u>not</u> consider the adoption, amendment, or repeal of the regulation described below at its December 18, 2025, meeting. The Commission will issue a new 30-day notice, with the date and time at which the proposed amendments to NGC Regulation 5.260 will be considered, once the Board has finalized its recommended draft for Commission consideration.

The public hearing noticed in Notice 2025-94 is scheduled to be held at or about the hour of 10:00 a.m. on December 18, 2025, at the following locations, for consideration of other regulation items identified in that notice; however, NGC Regulation 5.260 will <u>not</u> be considered at that meeting:

PROPOSED AMENDMENTS TO NGC REGULATION 5.260

PURPOSE: To amend NGC Regulation 5.260(2) to add definitions for certain terms; to amend NGC Regulation 5.260(4) to modify initial notification requirements; to amend NGC Regulation 5.260(4) to require the submission of an initial incident response report; to amend NGC Regulation 5.260(4) to add a provision requiring the submission of written status reports; to amend NGC Regulation 5.260(4) to add a waiver provision for the reporting requirements set forth in the subsection; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.
